Especially for students, who are used to the crowded Ruhr area, Australia and its vast outback offer a great change of scenery. Perth, where Murdoch University is located, is the fourth largest city in Australia. It has a broad range of cultural and social activities, a beach, as well as adventures and a variety of opportunities for everyone.

Due to our partnership, students of our Faculty who gain one of the highly coveted places to study in Perth receive a complete tuition waiver. All other costs may be covered through the DAAD's PROMOS stipend or other financing opportunities.

The next application deadline for the academic year of 2021/2022 is January 29, 2021. If you have any questions, we are happy to assist you!

What is it like to study in Bochum as a foreign student?

Interview: One of our Erasmus Students from Istanbul who was in Bochum in the winter semester 2019/20 answered our questions:

"I chose Bochum as destination for my Erasmus semester because of the university's academic performance, the availability of law education in English and the high number of international students.

"When I arrived, the variety of course options obviously made me very happy. I was a little worried about coming to a new country with a different education system but I didn't have any problem about selecting courses, ZfI Jura shared all details with me. Lecturers also answered me when I had a question. Additionally, every Monday at "Sprachcafé", students can come together and practice speaking the languages they want to learn. I don't even have time to get bored and I can learn new things while having fun.

"Bochum, in the heart of the Ruhr Area, is close to other beautiful cities of Germany. There are so many natural wonders and museums that I cannot count. It is a great chance for students to travel in NRW free of charge with their student card. In Bochum I recommend visiting the German Mining Museum and Zeiss Planetarium and the entertainment place called Bermuda especially on weekends. On campus my favorite places are the botanical garden and the area behind the Mensa where we can watch the view.

"Since I came from a cosmopolitan city like Istanbul, I thought I would get bored elsewhere, but on the contrary: I had a lot of fun in Bochum and improved my language skills, had information about different fields of law and law systems. I dream of being a student here again for my higher education. Bochum and the university campus became like my home. I collected a lot of amazing memories during my time in Bochum. I'll miss my friends, lecturers and tasty German desserts.

Congratulations to Our Jessup Moot Court Team 2020!



The Philip C. Jessup Moot Court competition is the largest public international law competition in the world with over 700 law schools participating from over 100 countries. Our Faculty has competed in the Jessup since 2003. This year's team consists of Nadine Grünhagen, Vanessa Blicke, Dilara Yaman and Paul Matthies, who were coached by Jule Giegling and Dr. Judit Beke-Martos together with last year's team (Ella Schönleben, Judith Prasse, Darius Bentrup and Rouven Diekjobst) as student coaches. The 2020 Jessup problem addressed multi-fora international litigation, the accountability of heads of state for war crimes, and fully autonomous weapons systems. At the German National Rounds in Göttingen our team finished 7th from 17 competing teams, while our written submission for the respondent won the Best Respondent Memorial Award. Congratulations!

The Certificate Program in Numbers



Since the winter semester of 2016/2017, the Zfi has been offering the "Anglo-American Law & Language" certificate program to provide students with knowledge of English legal terminology and Anglo-American law. This program consists of three obligatory and five elective courses and is completed with a final exam.

The courses are particularly suitable for those who are planning a stay abroad or would like to acquire an additional qualification for their future career in an international environment. Some courses also discuss current international topics.

So far over 60 students have successfully graduated from the program and earned a certificate. Another 85 students are currently enrolled in the program.

Foreign – Not English – Language Courses



Do you know that we also offer legal courses in foreign languages other than English? Maybe one of them is interesting for you!

Mr. Schwarz (more information about him on page 3) is teaching a course in which he is introducing Spanish law to you. The course is on Thursdays, from 2 p.m. to 4 p.m. in GD 2/468.

If you speak Turkish and would like to learn something about the Turkish Criminal Law you can participate in the course of Junior Professor Dr. Özeydin. Her course is taught in five-hour blocks on April 24, May 29, June 19 and 20 from 1 p.m. to 6 p.m.

Mrs. Campolucci offers an introduction to Italian law Mondays from 10 a.m. till noon in GD 1/468.

For all French enthusiasts we are currently working on a course offer for the upcoming semester.

All our courses fulfill the requirements and offer you the opportunity to earn your so-called "Fremdsprachenschein." At the same time, they allow you to practice and enhance your language skills, as well as to gain an insight into a new legal system.

For those planning a semester abroad, these courses offer the necessary preparation. All our courses have an obligatory attendance of 80%. The limited places in the courses are distributed through a computer-generated draw, so don't forget to register for the courses on eCampus. The teaching is scheduled to start in the week of April 20, 2020. Due to the restrictions following the current Corona pandemic, we need to reorganize some of our courses, so please continue to check our homepage for the latest updates. Thank you!

A Closer Look at: U.S. Intellectual Property Law



Just last year Katy Perry and her collaborators were found guilty of infringing another artist's copyrights with their song "Dark Horse". The year before that, in 2018, Apple and Samsung finally settled their seven-year-long dispute over Samsung's patent infringements with one of its smartphone models. Topics of intellectual property law, such as patents, trademarks, copyrights and trade secrets are perhaps more relevant today than ever. Mr. Hanrahan is a registered U.S. patent attorney based in Florida. He holds a B.Sc. from the University of Florida in Computer and Information Science Engineering and a J.D. from the University of Miami School of Law. In his course students learn about intellectual property rights and their interrelation to one another. Additionally, students discuss how to obtain protection for intellectual property rights and how to enforce them against an infringer.


Semester Abroad – Last Minute!
