Data Protection Law

Interested? You should be!



In the upcoming summer semester 2021, Dr. Hannah Ruschemeier will be teaching a new English-language legal course on "Data Protection Law - A comparative perspective with a focus on new technologies".

Since the General Data Protection Regulation (GDPR) was implemented in 2018 data protection has been a "Bestseller" in international and labour law. It is a big part of our daily lives and concerns us everywhere we go. Its implications are highly relevant in a society which is shaped by online communication, big data analyses and monopolies of social-media platforms.

The upcoming course will examine the history, principles, and constitutional aspects of Data Protection, emphasizing the impact of new technologies such as Artificial Intelligence. Besides the European approach of the GDPR towards privacy, the course will explore the international comprehension of Data Protection as well as the different national legal strategies from a comparative point of view.

The aim of the course is to combine theoretical legal aspects with the practical impacts of Data Protection.

Dr. Ruschemeier is a research fellow in charge of the project "AI in State and Public Administration" at the Center for Advanced Internet Studies in Bochum and a postdoc researcher at the German University for Administrative Sciences in Speyer. The course on data protection law will be her second course here at the RUB, following the course on artificial intelligence, that she taught last semester.

The course will be taught via Zoom on Tuesday from 10 am until noon starting April 20, 2021. If you are interested in participating, you can register for the course through eCampus until April 15, 2021 at midnight.

How does the Program work?

The certificate program consists of eight courses, three of which are required courses ("core courses") and five others, which every student can select themselves ("elective courses"). In order to pass the core courses students will have to write a written exam, while the elective courses can be passed without an exam.

The core courses are:

- **Introduction to American Law**
- **U.S. Constitutional Law I: State and Governance**
- **U.S. Constitutional Law II: Fundamental Rights**

The elective courses can be chosen from the entire course catalogue which contains courses like U.S. Contract Law, U.S. Intellectual Property Law, International Dispute Settlement, or International Dimensions of Law. The program ends with a final exam that consists of an oral and a written exam.

The certificate program is a great way for every student to set themselves apart from the crowd and gain additional qualifications; especially in a professional environment that will only become more international in the future. 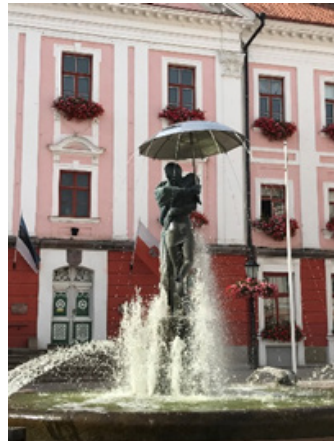
